Event Descriptions:

In-House Counsel Conference

April 16, 2026

Pennsylvania Convention Center

Average Attendance = 800 people

- ACCGP's In-House Counsel Conference (IHCC) is our largest event of the year. The event features over 20 CLE presentations, 30+ marketing tables, complimentary professional headshots for all attendees, a puppy park with adoptable dogs, chair massages, breakfast, lunch and a networking cocktail reception.
- CLE presentations should consist of four speakers (a maximum of three (3) representatives from your firm/organization, and one (1) or more in-house counsel of your choosing).
- A marketing table is available for up to two (2) marketing representatives to provide promotional materials to attendees.
- No more than five (5) representatives (exclusive of in-house panelists) may be present at the Conference (and attendees are not interchangeable).
- Law firm attendees are permitted to attend the full day conference, including all CLE sessions, breakfast, lunch and cocktail reception.
- All food and beverage costs are included in the sponsorship fee.

Fall CLE Institute - *NEW FOR 2026!*

October 2026

- ACCGP will be combining some of our in-person practice area-specific CLE Institutes into one larger Institute in the fall.
- Only the Diamond, Emerald and Platinum sponsors will have the opportunity to present a CLE session and have a marketing table in the exhibit area.
- Gold sponsors are invited to participate in the Fall Institute with a marketing table.
- CLE presentations should consist of four speakers (a maximum of three (3) representatives from your firm/organization, and one (1) or more in-house counsel of your choosing).

Inclusion Summit

December 2026

- ACCGP's Women Lawyers Network and Diversity Committee will be joining forces to present an Inclusion Summit to cover various topics focusing on diversity, gender equality, accessibility, etc.
- The Inclusion Summit will be a full-day program featuring CLE programs presented by our Diamond, Emerald and Platinum sponsors only. The Diamond sponsor will have the opportunity to present the opening general session.

Corporate Counsel University

- The Corporate Counsel University is a half-day program geared toward in-house counsel who are new to in-house practice, while also offering introductory programs in general practice areas that may be of interest to more experienced lawyers. The Corporate Counsel University consists of one-hour CLE seminars given by our Diamond and Emerald and sponsors.
- CLE presentations should consist of four speakers (a maximum of three (3) representatives from your firm/organization, and one (1) or more in-house counsel of your choosing).
- A marketing table is available for up to two (2) marketing representatives to provide promotional materials to attendees.
- No more than five (5) representatives (exclusive of in-house panelists) may be present at the Conference (and attendees are not interchangeable).
- All food and beverage costs are included in the sponsorship fee.

Premium Networking/Social Event

- These events are networking opportunities for members and sponsors at various locations throughout the Greater Philadelphia Area. The events are limited to Diamond, Emerald and Platinum sponsors.

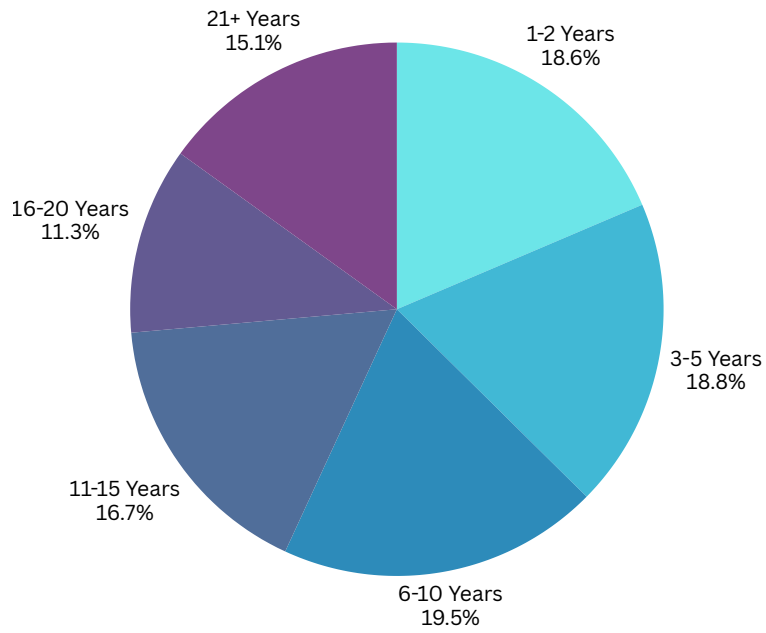
Sponsor Reception/In-House Lawyer Perspective Program

September 2026

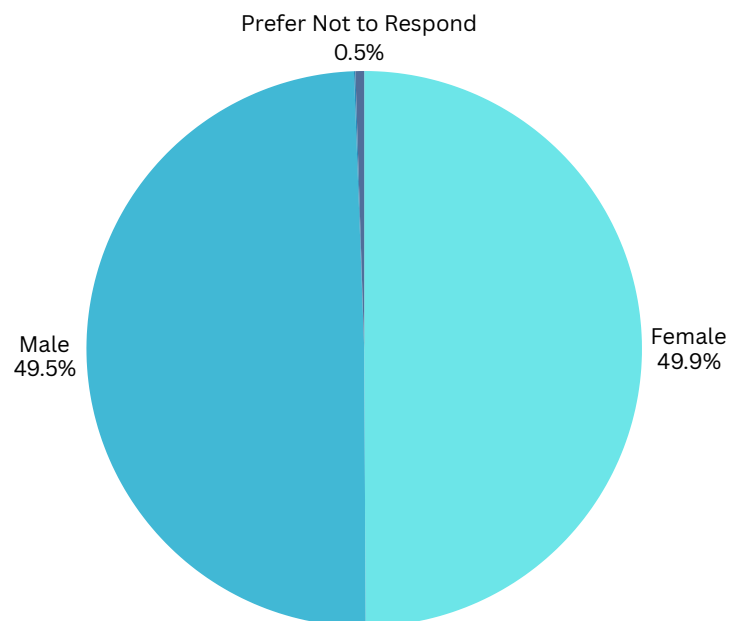

By Years in House

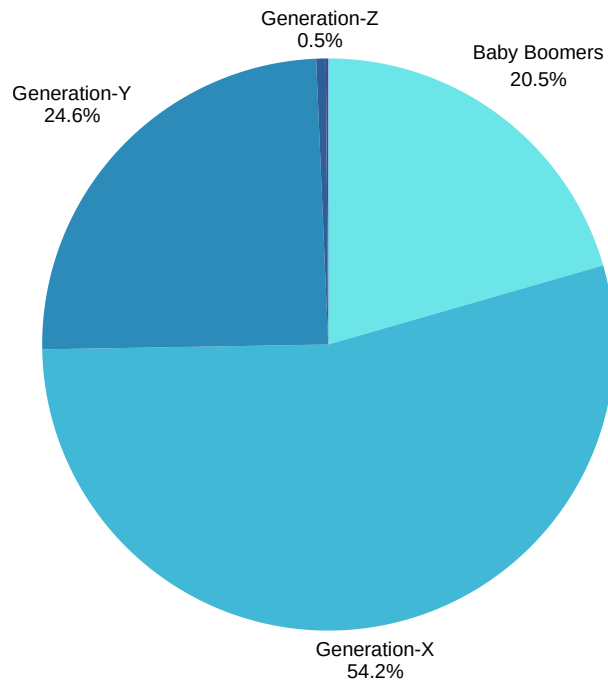


By Gender

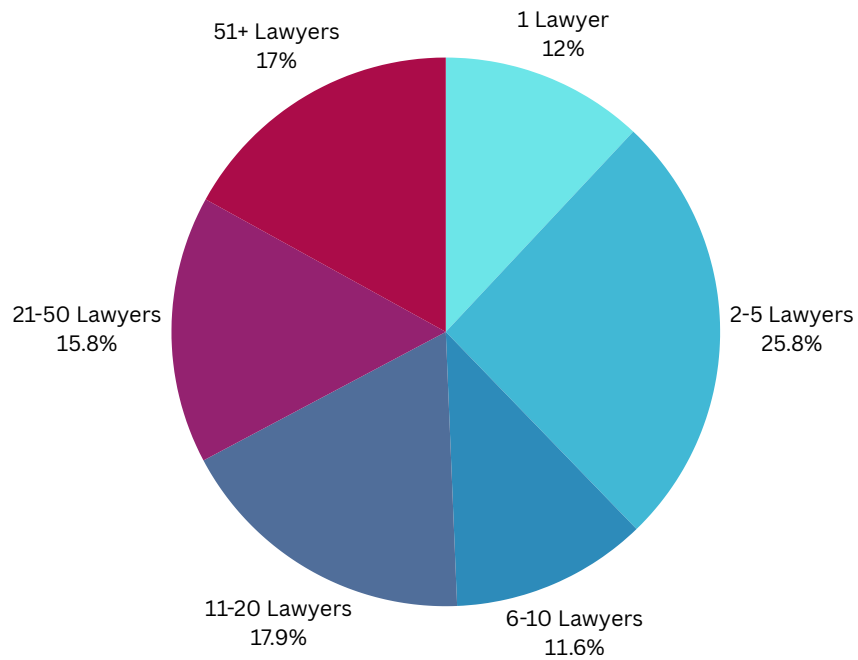




Generational Diversity

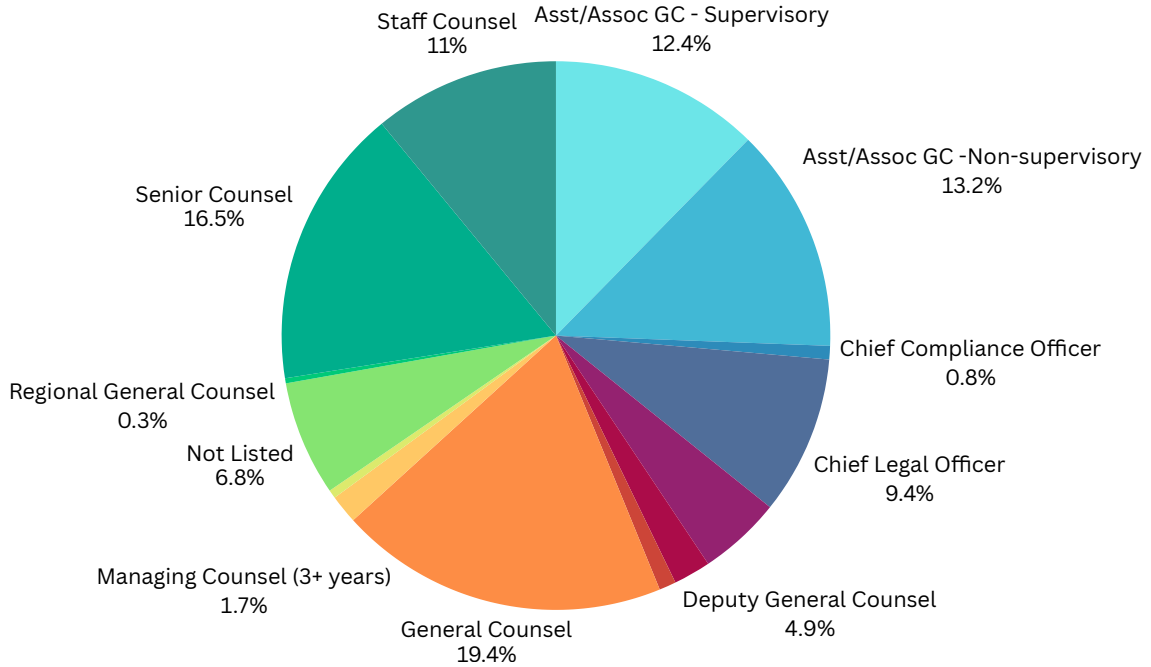


By Size of Legal Department
